

## Volusia County Gun & Hunt Club RSO Program

1. RSO's are required to **average 8 hours per month** for a total of **24 hours** per quarter, as described below, thus a total of **96 hours** per year. Those in compliance will receive a **Single Membership quarterly monetary credit**. **Unless otherwise exempted, RSO's not in compliance and not exempted will not receive a quarterly monetary credit and will receive an invoice for the quarter for which payment is expected in order to maintain their RSO status. Please note, RSO's who remain non-compliant for two quarters may be removed from the RSO Program.**

1<sup>st</sup> Quarter = January, February, March

2<sup>nd</sup> Quarter = April, May, June

3<sup>rd</sup> Quarter = July, August, September

4<sup>th</sup> Quarter = October, November, December

Should an RSO wish to accelerate the yearly 96-hour requirement **they may do so at a maximum rate of 12 hours per month**. This will enable completion of the required **96 hours per year** in only eight months. **Upon completion of the required 96 hours per year you may not reschedule unless called upon to do so with prior authorization.**

**You may not schedule more than 12 hours per month** unless called upon to do so with prior authorization. Doing so will result in the additional scheduled hours being deleted and you being notified, **the first time**. If you continue to schedule more than 12 hours per month after the initial notification, you will be deleted and not notified. **There are no restrictions on what days you may schedule as long as you do not exceed 12 hours per month.**

2. Except for competitive events additional privileges include free range use for four non-member guests when accompanied by the RSO, and range use for RSO's and two non-member guests on Monday's from 9am - 2pm. **If members wish this privilege, they must become RSO's.**

3. Our published hours of operation are 9am-5pm, Tuesday - Sunday, consisting of two four hour shifts from 9am-1pm and 1pm-5pm. RSO's may work either one shift for a total of four hours or both shifts for a total of eight hours. On Wednesdays, Saturdays, and Sundays, RSO shifts will have a 1.5 multiplier applied; e.g. four hours equals six hours and eight hours equals 12 hours.

4. Two RSO's will receive credit for the AM & PM shifts on Tuesday, Thursday, Friday, Saturday, and Sunday. **Both shifts must have one person signed on before you may sign on as the second RSO.** Three RSO's will receive credit for the AM & PM Wednesday shifts. **Both shifts must have at least one person signed on before you may sign on as the second person and two persons must be signed on before you may sign on as the third RSO.**

5. As RSO's we are tasked with the responsibility of providing our members with a safe, secure, and fun place for the whole family to enjoy the shooting sports. With this in mind, **on duty RSO's are not allowed to practice shooting and since members must be with their guests while on the firing line, they are not allowed to have guests.**

6. **RSO's are required to monitor the Schedule for ongoing updates, fill in where needed, and be intimately familiar with the RSO Program and current Range Rules and Operational Procedures.**

7. In order to serve as a VCGHC RSO you are required to maintain a valid NRA RSO Rating and submit a copy thereof upon renewal.
